He has published extensively on the political economy of development and development macroeconomics. His most recent book is *Neoliberalism: A Critical Reader* (ed., with D. Johnston, London: Pluto 2005).

Iyanatul Islam

Iyanatul Islam is *Professor, Department of International Business and Asian Studies, Griffith University, Australia*. He has produced over *twenty policy assessments* pertaining to poverty, labour markets and human resource development for various international agencies [ILO, UNDP, Asian Development Bank). He has written regularly in international refereed journals (e.g. *Cambridge Journal of Economics*, *Bulletin of Indonesian Economic Studies*, *Canadian Journal of Development Studies*, *World Development*) and has co-authored several books on East Asian political economy (published through Routledge, Edward Elgar, Oxford University Press). Professor Islam is one of the founding editors of the *Journal of Asia-Pacific Economy* (published by Routledge, London and New York) and a member of the editorial board of the University of Michigan-based *Journal of Asian Business*.

Rizwanul Islam

Rizwanul Islam is Director, Recovery and Reconstruction Department in the Employment Sector of the International Labour Office, Geneva. His previous positions include Director, ILO's Asian Regional Team for Employment Promotion, and Director, ILO South Asia Multidisciplinary Advisory Team. Mr. Islam did his Ph.D. in Economics at the London School of Economics and Political Science. His research interests are in the field of employment and poverty in general; and he has published journal articles and books in this field. His recent publications include a volume (edited jointly with Gordon Betcherman of the World Bank) titled East Asian Labour Markets and the Economic Crisis: Impacts, Responses and Lessons. Mr. Islam's current research is on the nexus of economic growth, employment and poverty; his edited volume on the topic is awaiting publication.

Selim Jahan

Dr. Selim Jahan has been serving since 2001 as the Senior Adviser, Employment for Poverty Reduction in the Bureau for Development Policy (BDP), United Nations Development Programme (UNDP) in New York. In his present capacity, Dr. Jahan is engaged, on the one hand, in research on such issues as pro-poor economic and social policies in areas of health, education, social protection, gender equality, employment-led growth, labour market concerns and social inclusion, and on the other, in country-level policy advice and in inter-agency collaboration on these issues. He is also deeply involved in Millennium Development Goals (MDG) Country Reports and the management of Poverty Thematic Trust Fund (TTF).

Prior to his present position, Dr. Jahan served as the Deputy Director of the Human Development Report Office (HDRO) for five years (1996-2001). He was also a Policy Advisor in HDRO during the period (1992-1996). During his stay at the HDRO,

he was a member of the Core Team that authored nine global Human Development Reports (1993-2001). He was also involved in the Core Team of a number of National Human Development Reports (NHDRs), including one of the first NHDRs produced in his own country Bangladesh in 1991.

Before joining UNDP in 1992, Dr. Jahan held different positions in universities, national governments and other international organizations. He was a Lecturer of Economics (1974-77) and Professor of Economics and Director of the Economic Research Unit, University of Dhaka, Bangladesh (1984-89). He was a Lecturer, Department of Economics, McGill University, Montreal, Canada (1983-84), a Visiting Fellow, Cambridge University, U.K. (1987-88), and a Visiting Scholar, School Of Public Policy, University of Maryland, U.S.A (1992). Dr. Jahan served as an Economic Adviser, USAID, Dhaka, Bangladesh (1988), and as the Economic Adviser, Planning Commission, Government of Bangladesh, (1989-90). He has also worked as Adviser and Consultant to various international organizations including ILO, UNDP, UNESCO, and the World Bank during the 1980s and the early 1990s.

Dr. Jahan served as a Member of the Financial Sector Reform Commission, Government of Bangladesh (1988), Jamuna Bridge Advisory Panel (1989) and the President's Task Force on Macroeconomic Framework of Bangladesh (1991). He was the Secretary General of the Bangladesh Economic Association (1990-91) and Vice-President of the Commonwealth Association for Local Action (1992- 96).

Dr. Jahan holds a Ph.D in Economics from McGill University, Montreal, Canada, where he was Commonwealth Scholar (1977-82). He had his undergraduate and graduate studies in Economics at University of Dhaka, Bangladesh.

Dr. Selim Jahan is the author of six books and more than 150 articles in various national and international academic journals. He contributes regularly to various newspapers and periodicals. He is married and has two daughters.

Azizur Rahman Khan

Azizur Rahman Khan is Professor of Economics at University of California, Riverside. Previous positions held by him include: Research Director, Pakistan Institute of Development Economics and Bangladesh Institute of Development Studies; Lecturer in Economics, London School of Economics; Staff Member of ILO's World Employment Programme; and Senior Economist at The World Bank. His current research interests include: analysis of employment, income distribution and poverty in developing countries; transitional problems of inequality, poverty and unemployment in the former centrally-planned countries; comparative analysis of different agrarian systems; and the consequences of globalization on growth and distribution in developing countries. His most recent book (jointly with Carl Riskin) is *Inequality and Poverty in China in the Age of Globalization* (Oxford University Press, 2001).

M. Muqtada is a senior economist in the Employment Strategy Department of the International Labour Organization in Geneva. He holds a PhD in Economics from the University of Cambridge, UK. Prior to joining the ILO, he taught at the Department of Economics, University of Dhaka. He has carried out extensive research on issues in employment and development. He has published several articles and books on labour markets, employment, poverty and structural adjustment. His books include *The elusive target: An evaluation of target group approaches to employment generation* (editor), ILO/ARTEP, New Delhi; *Employment expansion and macroeconomic stability under increasing globalization* (co-edited with Azizur Rahman Khan), MacMillan Press Ltd., UK and St. Martin's Press, USA; and *Bangladesh: Economic and Social Challenges of Globalization* (co-edited with Andrea Singh and M. Ali Rashid, University Press Ltd., Dhaka, 2002).

Siddiq Osmani

Siddiq Osmani is Professor of Development Economics at the University of Ulster, United Kingdom. He obtained Ph.D in economics from the London School of Economics and then worked at the Bangladesh Institute of Development Studies, Dhaka and at the World Institute for Development Economics Research, Helsinki before joining the University of Ulster. He has published widely on issues related to poverty, inequality, hunger, famine, nutrition, rights-based approach to development, and development problems in general, and his books include Economic Inequality and Group Welfare and Nutrition and Poverty.

Robert Pollin

Robert Pollin is Professor of Economics and founding Co-Director of the Political Economy Research Institute at U Mass Amherst. He received a Ph.D. in economics from the New School for Social Research in New York City in 1982. His main areas of research are macroeconomics, conditions for low-wage workers in the U.S. and globally, and the analysis of financial markets. Recent books by him include *Contours of Descent: U.S. Economic Fractures and the Landscape of Global Austerity* (Verso 2003); *The Living Wage: Building a Fair Economy* (The New Press, 1998), and the edited volumes *Globalization and Progressive Economic Policy* (with Dean Baker and Gerald Epstein, Cambridge, 1998); *The Macroeconomics of Saving, Finance, and Investment* (University of Michigan Press, 1997); and *Transforming the U.S. Financial System* (with Gary Dimski and Gerald Epstein, M.E. Sharpe 1993). In the area of labor market policies, Professor Pollin has written extensively on the viability of so-called "living wage" policies, including as policy makers have proposed them in Los Angeles; Santa Monica, California; New Orleans, Louisiana; and Santa Fe, New Mexico. He is currently completing a manuscript on the economics of global sweatshops with Professor James Heintz of PERI. In separate areas of policy work, he is currently directing a project on employment-targeted macroeconomic policies for South Africa, under the auspices of the United Nations Development Program (UNDP). He has worked previously with the UNDP in Bolivia, and has worked with the Joint Economic Committee of the U.S. Congress and as a member of the Capital Formation Sub council of the U.S. Competitiveness Policy Council.
